Android studio universal adb driver

If you are developing in Windows and want to connect a device for testing, you need to install the appropriate USB drive. This page provides links to the websites of several original equipment manufacturers (OEMs) where you can download the appropriate USB drive for your device. If you are developing on Mac OS X or Linux, you should not need a USB drive. Read using Hardware Devices instead. To connect and debug any of the Google Nexus devices that use Windows, you need to install the Google USB drive. First install a USB drive, find the appropriate driver for your device from the OEM drivers table below. After downloading your USB drive, follow these instructions to install or upgrade the drive, depending on your version of Windows and whether you installed it for the first time, or whether you upgraded an existing drive.
